

The Theme

Invasive Alien Species (IAS) and their impact to the environment are one of the key topics addressed by LIFE projects over the years.

LIFE is an important instrument in relation to the development and further implementation of EU policy and legislation on the issue. On 1 January 2015 the new EU Regulation 1143/2014 on invasive alien species entered into force.

This Regulation seeks to address the problem of invasive alien species in a comprehensive manner so as to protect native biodiversity and ecosystem services, as well as to minimize and mitigate the human health or economic impacts that these species can have. The Regulation foresees three types of interventions: prevention, early detection and rapid eradication, and management. The contribution of the LIFE programme has been pivotal in this context, thanks to a number of projects including innovative actions and best practices, along with studies aimed at supporting the further implementation of the IAS regulation, e.g. in relation to the risk assessment to inform the evolution of the list of species of Union Concern.


